RATIONALE FOR THE COURSE:

Introduction to Law & Ethics is designed to familiarize the paralegal student with the legal system and the professional standards demanded of all of its members.

COURSE DESCRIPTION:

This course provides a general introduction to law, including courts, legal terminology, procedures, systems, and laws of society. Emphasis is on ethics and the role of the paralegal in the legal system.
