RATIONALE FOR THE COURSE:

The purpose of this course is to assist paralegal students in bridging the gap between the classroom and the real working world of today's paralegal. The student is required to work under the supervision of an attorney or paralegal in a law firm, governmental agency, or other organization where legal work is being performed for a total of **90 hours within the semester or alternatively complete the Law Practice Internship Online Simulation**. The student must also attend traditional or on-line classes addressing issues relevant to serving as an intern and obtaining employment upon graduation. The student will maintain accurate records of the substantive tasks performed and report on his/her hands-on experience.

COURSE DESCRIPTION:

This course includes the application of substantive knowledge in a practical situation as a paralegal.

PREREQUISITES/CO-REQUISITES:

Successful completion of all LEG courses by the third semester for Certificate students and fifth semester for Associate students of the Paralegal Program and at least a 2.0 G.P.A.

GRADING SYSTEM:

State the College’s or departmental grading system as delineated in the Catalog. Please note the College adheres to a 10 point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below. You must have your Dean’s approval if changes in the scale are made.

The grade earned by the student intern will be as follows:

“S” = SATISFACTORY and does not affect the student’s G.P.A. The student will earn 3.0 credit hours, but 0 quality points.

“U” = UNSATISFACTORY and does not affect the student’s G.P.A. The student will earn 0 credit hours and 0 quality points.

“I” = INCOMPLETE and does not affect the student’s G.P.A. However, the **“I”** converts to an **“F”** automatically at the end of the next semester if the course requirements are not completed.

Grades earned in courses impact academic progression and financial aid status. Before withdrawing from a course, be sure to talk with your instructor and financial aid counselor about the implications of that course of action. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. Please refer to the [academic calendar](#) for deadlines for add/drop. You must attend at least one meeting of all of your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

For a 14 week course (fall and spring) the allowed number of absences for a MW or TR class is as follows: 5 absences are allowed regardless of reason. After the allowed number of misses, the student will be dropped from the course with a W or a WF.

For a 10 week course (summer) the allowed number of absences for courses meeting twice a week is 4 absences. After missing the maximum number of allowed absences a student will be dropped from the course with a W or a WF.

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, and if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.
