RATIONALE FOR THE COURSE:

Business Applications in the Law Office provides an overview of computer programs, skills, tools and software programs that are essential to being a successful paralegal.

COURSE DESCRIPTION:

This course introduces computer applications in various business transaction settings using general and legal software programs. Students will learn Microsoft Office components including Word, Excel, OneNote, PowerPoint and Outlook. Students will also explore legal specific software including Sanction, TrialDirector, Clio, CaseMap, TimeMap, LiveNote, FileSite and Concordance.

***Online/Hybrid** courses require students to complete the DLI Online Student Orientation prior to completing an online course. The DLI Online Student Orientation can be found in WaveNet, under the My Student tab.

REQUIRED MATERIALS:

There is no textbook required for this course. However, students **must join the National Society for Legal Technology (NSLT)**. There are two options for joining NSLT.

Option 1 Go to the website located at [National Legal Tech Society Link](#) and select Student. From the homepage, select the "Join today!" button to go to the registration page. The membership fee is \$120 and may be paid using a credit card, debit card, or PayPal account. Once you are registered, select the "eLearning Portal" tab that will appear on the homepage when signed in to the NSLT site. The eLearning Portal will ask you to register for access to the learning portal. There is not

a separate cost for registration on the eLearning Portal. The second registration creates a user profile to track your progress through the certificate process. Your membership is valid for 1-year from the date of registration, and the membership fee includes the cost of earning their Legal Technology Certificate.

Option 2 You may purchase the same access through the college Barnes and Noble Bookstore. Please note that the bookstore will charge \$50+ more for the same membership/access. To purchase your membership from the college bookstore, follow the instructions below:
