RATIONALE FOR THE COURSE:

College Algebra is designed for students who intend to transfer to a four-year institution or who intend to take calculus, MAT 130 or MAT 140. All skills are learned with a focus on problem solving, so that the logical thought processes become a useful tool in their other classes.

COURSE DESCRIPTION:

This course includes the following topics: polynomial, rational, logarithmic, and exponential functions; inequalities; systems of equations and inequalities; matrices; and solutions of higher degree polynomials.

Credit level MAT 102 Minimum Grade of C or Credit level MAT 102 Minimum Grade of TC or New SAT Mathematics 560 or ACT Math 22 or Multiple Measures Math 1.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student, and a student may not be permitted to reenroll. Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.
