RATIONALE FOR THE COURSE:

Selected topics covered in Finite College Mathematics are widely applicable to the fields of programming, networking and business. The course also serves as an ideal survey of mathematics course for associate of arts or associate of science students.

COURSE DESCRIPTION:

This course includes the following topics: logic; sets; Venn Diagrams; counting problems; probability; matrices; systems of equations; linear programming, including the simplex method and applications; graphs; and networks. (Prerequisite: a college algebra course)

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course.
