#### **RATIONALE FOR THE COURSE:**

MTT 111 is a required course in the Machine Tool Technology Program. MTT 111 will develop skill sets in the proficient use and set up of most manual machine tool equipment. Enforcement of measuring instrument and inspection equipment skills will also be applied.

#### **COURSE DESCRIPTION:**

This course is an introduction to the basic operation of machine shop equipment.
