COURSE PREFIX: MTT 254

COURSE TITLE: CNC Programming I

CONTACT HOURS: 7.0

CREDIT HOURS: 3.0

RATIONALE FOR THE COURSE:

MTT 254 is a required course in the Machine Tool Technology Program. MTT 254 will develop skill sets in the proficient use programming of CNC machines.

COURSE DESCRIPTION:

This course is a study of CNC programming, including machine language and computer assisted programming.

PREREQUISITES/CO-REQUISITES:

COMPASS Reading 65, COMPASS Writing 31, and COMPASS Pre-Algebra 40 or SAT Critical Reading 380 and SAT Mathematics 400
or ACT English 12, ACT Reading 14, and ACT Math 16.

***Online/Hybrid** courses require students to complete the [Dli Orientation Video](#) prior to enrolling in an online course.

REQUIRED MATERIALS:

Textbook required (Caminstructor 2021 Training Guide Mill 3D). Notebook dedicated to CAD/CAM programming.

Part IV: Attendance

Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
