COURSE TITLE: CNC Programming II

RATIONALE FOR THE COURSE:

MTT 255 is a required course in the Machine Tool Technology Program. MTT 255 will develop skill sets in the proficient use and programming of 4 and 5 axis CNC machines.

COURSE DESCRIPTION:

This course is a study of CNC programming, including machine language and computer assisted programming utilizing Mastercam cad/cam software.

PREREQUISITES/CO-REQUISITES:

COMPASS Reading 65, COMPASS Writing 31, and COMPASS Pre-Algebra 40 or SAT Critical Reading 380 and SAT Mathematics 400 or ACT English 12, ACT Reading 14, and ACT Math 16.

***Online/Hybrid** courses require students to complete the [DLi Orientation Video](#) prior to enrolling in an online course.

REQUIRED MATERIALS:

Textbook required (Mastercam 2021 Training Guide Mill 4 and 5 axis). Notebook dedicated to CAD/CAM programming.

5. Clean and prepare material for machining.
6. Utilize efficient tool paths for part creation.
