RATIONALE FOR THE COURSE:

MUS 105 is a survey of the music of western civilization from the available pre-medieval evidence to modern times. The purpose of this class is for each student to broaden his/her scope and understanding of music, and its various styles. This will be accomplished through a comprehensive and meticulous investigation of musical elements, composers' lives, musical forms, style periods, and listening assignments. There will also be a cross-reference of musical characteristics that are indigenous to more than one style period. Each student will grasp a sufficient number of concepts so as to feel competent about picking out in sound, special nuances in all types of music.

COURSE DESCRIPTION:

This course is an introduction to the study of music with focus on the elements of music and their relationships, the musical characteristics of representative works and composers, common musical forms and genres of various western and non-western historical style periods, and appropriate listening experiences.

- If academic misconduct is substantiated to the Professor's satisfaction, the Professor notifies the student of the sanction to be imposed, consisting of one of the following:

- Assign a grade of zero to the test, assignment, etc. involved in the academic misconduct.
- Assign a failing grade for the course (with consultation on student academic options including the appeal process
- Require the student to withdraw from the course

• Within five (5) working days of the meeting with the student, the Professor must provide a written explanation of the incident and any sanction imposed to the Chief Instructional Officer (Dr. Jennifer Wilbanks). 1. Identify and define the basic elements of music including: pitch, dynamics, tone color, rhythm, notation, melody, harmony, phrase, form, and texture.

- 2. Identify and discuss the characteristics of standard musical instruments.
- 3. Identify the characteristics of historical periods in music.

4. Identify the general characteristics of each period in western music from the Middle Ages to the 21st century.

5. Identify important composers of each period and be able to discuss key features of their music.

6. Identify and discuss important musical forms and representative compositions from each musical period.

- 7. Identify aural elements of music.
- 8. Identify differences in pitch, dynamics and tone color.
- 9. Identify different rhythms.
- 10. Identify standard musical instruments.
- 11. Identify basic musical forms.
