RATIONALE FOR THE COURSE:

Forestry is a profession dealing with the management of land resources. Effective management requires understanding the spatial distribution or location of resources (timber, grass, roads, etc.). The course focuses on the manipulation of information in the form of maps, satellite imagery, drone acquired imagery, Global Positioning Systems (GPS) and Geographic Information Systems (GIS). These skills are fundamental for managing resources for the benefit of timber production, wildlife management, etc.

COURSE DESCRIPTION:

This course is the study of Geographic Information Systems (GIS) concepts, including coordinate systems, projections, datums, data models and sources, spatial statistics, queries and analyses, and basic cartographic principles. Emphasis is on applications within the NRM field.

PREREQUISITES/CO-REQUISITES:

Module #1

Materials Covered: Remote Sensing and GIS

*Assessment(s): Unit Test
Skill based labs

Learning Outcomes:

1. Define remote sensing and explain how remotely sensed data are used in Geographic Information Systems (GIS)
2. Identify different sources of remotely sensed data, including aerial imagery, satellite imagery, LiDAR, SLAR and drones.
3. Identify and interpret remotely sensed data acquired from aerial imagery, satellite imagery, LiDAR, SLAR and drones.
 - a. Identify timber types and drainage locations on imagery.
 - b. Interpret land usage patterns observed on imagery.
 - c. Identify roads, buildings, geologic features using imagery.
4. Introduce heads-up digitizing in GIS.

Module #2

Materials Covered: Map Projections and Coordinate Systems in GIS, Integrating GPS

*Assessment(s): Unit Test
Skill based labs

Learning Outcomes:

1. Define geographic coordinate systems and map projections
2. Identify the most commonly used geographic and projected coordinate systems used in GIS and GPS.
3. Learn how to project data manually, project data "on the fly" and perform geographic transformations.
4. Collect accurate data with a GPS receiver.
5. Manage, edit and project data collected with a GPS receiver.
6. Develop maps using projected/transformed data and data collected with a GPS receiver.

Module #3

Materials Covered: Data Management, Editing and Analysis

*Assessment(s): Unit Test

Skill based labs

Learning Outcomes:

1. Create, delete, edit, split and merge features using various construction tools.
2. Practice editing with snapping and modify a snapping environment.
3. Define a geodatabase and develop geodatabases, feature classes and features.
4. Convert shapefiles to feature classes.
5. Create, edit and calculate attributes; Modify, expand and relate attribute tables.
6. Use selection, query, join and relate tools.
7. Dissolve, clip, buffer and overlay features.

Module #4

Materials Covered: Advanced Map Creation, Online Maps and Interactive Maps

*Assessment(s): Unit Test

Skill based labs

Learning Outcomes:

1. Develop a user friendly map template.
2. Define appropriate map symbols and create custom map symbols.
3. Use labels, define rules for label placement, create graphic and dynamic labels.
4. Create maps with various print sizes and determine how to adjust symbols, labels, and text to scale.
5. Create online maps using ArcGIS Online and ArcPro.
6. Create an interactive online map.

Materials Covered: Analyzing Geospatial Data, Capstone Project

*Assessment(s): Skill based labs

Capstone Project

Skills Based Final – **PLO Forestry #2 – Navigate/mark waypoints using GPS (current technology), upload/download data to/from GIS software, delineate forest stand boundaries and calculate land areas within GIS based on GPS waypoints**

Learning Outcomes:

1. Explore Spatial Analyst.
2. Convert polygon data to raster data and reclassify raster data.
3. Create a plan for capstone project including data needs, final product and end user.
4. Collect data for capstone project.
5. Create a template and interface for capstone project.
6. Present capstone project to class either in-person or in an online interactive environment.

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 – Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student, and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
