RATIONALE FOR THE COURSE:

The course is designed to provide students with a basic understanding of the dynamics between forest management and wildlife. The student will be exposed to the fundamentals of the science of wildlife management.

COURSE DESCRIPTION:

This course is a basic study and application of management practices which are beneficial to wildlife. Methods for increasing food production, developing water sources, providing cover requirements, and improving wetlands are included.
