CONTACT HOURS: 3-0-3 CREDIT HOURS: 3

RATIONALE FOR THE COURSE:

This course will offer the Computerized Tomography student hands-on experience in Computerized Tomography. RAD 140 takes place in the clinical education centers. This course is composed of rotations within the Medical Imaging CAT Scan Department with an emphasis on practicing Procedures and Positioning of the human body to include but not limited to the Thorax, upper and lower limbs, abdomen, shoulder, pelvic and hip, and vertebral column. This practicum will correlate with RAD 135, RAD 120, RAD 145, RAD 103 and AHS 206.

The students' clinical education is conducted under the direct supervision of the clinical instructor, as well as all staff technologists. Also, scheduled/unscheduled visits from college staff will occur.

COURSE DESCRIPTION:

This course provides students with clinical experience in basic CT scanning. The student will explore techniques related to patient safety, radiation protection, and exam protocols.

AHS206, RAD103, RAD135, RAD145, RAD120

This course requires 15 hours/week of clinical participation. You will record your clinical attendance on the provided attendance sheet and have your supervising CT Technologist sign authenticity each week. Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, and if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.
