#### **RATIONALE FOR THE COURSE:**

This is the 2nd in a series of 6 courses that offer the Radiology student hands-on experience in Applied Radiography. RAD 268 takes place in the clinical education centers. This course is composed of rotations through the entire Medical Imaging department with an emphasis on practicing Procedures and Positioning of the Thoracic, upper and lower limbs, abdomen, shoulder, pelvic and hip, and vertebral column. This practicum will correlate with RAD 130- Procedures and Positioning class.

The students' clinical education is conducted under the direct supervision of the clinical instructor, as well as all staff technologists. Also, scheduled visits from college staff will occur.

#### **COURSE DESCRIPTION:**

This course includes the use of radiographic equipment and performance of radiographic procedures within the clinical environment of the hospital.

RAD 256

If a student is monitoring for an emergency, please notify and obtain permission from the Clinical Preceptor prior to clinic and switch cell phone ringers to vibrate.

5.4 The program assures that medical imaging procedures are performed under the appropriate supervision of a qualified radiographer.

The JRCERT defines direct supervision as student supervision by a qualified radiographer who:

- reviews the procedure in relation to the student's achievement,
- evaluates the condition of the patient in relation to the student's knowledge,
- is physically present during the conduct of the procedure, and
- reviews and approves the procedure and/or image.

Students must be directly supervised until competency is achieved. Once students have achieved competency, they may work under indirect supervision. The JRCERT defines indirect supervision as student supervision provided by a qualified radiographer who is immediately available to assist students regardless of the level of student achievement.

Repeat images must be completed under direct supervision. The presence of a qualified radiographer during the repeat of an unsatisfactory image assures patient safety and proper educational practices.

Students must be directly supervised during surgical and all mobile, including mobile fluoroscopy, procedures regardless of the level of competency.

Failure to comply with JRCERT Standard 5.4 will result in a Final written warning for the first offense, second offense will result in a Second Final written warning, and dismissal from the program

As a matter of courtesy to other students and your professor, please turn off cell phones and other communication/entertainment devices before class begins. If you are monitoring for an emergency, please notify your professor prior to class and switch cell phone ringers to vibrate.

#### **GRADING SYSTEM:**
