RATIONALE FOR THE COURSE:

Students may enroll in SPA 102 in order to satisfy their particular program's requirements and/or to enhance their personal and professional growth as a result of developing an ability to communicate at a basic level in Spanish in everyday situations.

COURSE DESCRIPTION:

This Course continues the development of the basic language skills and the study of Hispanic cultures.

PREREQUISITES/CO-REQUISITES:

(Credit level SPA 101 Minimum Grade of C or Credit level SPA 101 Minimum Grade of TC)

REQUIRED MATERIALS:

ADDITIONAL REQUIREMENTS:

Students will need access to a recording device that allows one to listen, record and save to an audio and video file.

Students will need access to technology that allows remote proctoring if taking an online course and planning to take assessments in a remote area. (Not a live testing site)

Proctor fees may be applicable in the event that proctored exams cannot be taken on one of our campus testing sites.

Access to Desire2Learn (D2L), HGTC's learning management system (LMS) used for course materials.

Access to myHGTC portal for student self-services.

COURSE LEARNING OUTCOMES and ASSESSMENTS*:

All successful SPA 102 students will be able to:

- 1. Ask and give directions.
- 2. Demonstrate their mastery of the Spanish present tenses by using affirmative and negative sentences.
- 3. Conjugate verbs grammatically which have stem changes and irregular 1st person conjugations.
- 4. Demonstrate the function and syntax of types of words such as direct and indirect object pronouns, demonstrative adjectives and pronouns.
- 5. Offer information referring to present, past and future actions.
- 6. Express reflexive constructions about themselves and others with object pronouns in present and past tenses.
- 7. Incorporate idiomatic expressions into Spanish conversation.

- 8. Discuss the weather incorporating world geography as occurs in natural conversation.
- 9. Ask and offer basic personal information changing from present to past and future constructions as occurs in natural conversation.
- 10. Demonstrate their appreciation of diversity and mutual respect towards others by establishing common likes and dislikes

GRADING SYSTEM:

Please note the College adheres to a 10-point grading scale A = 100 - 90, B = 89 - 80, C = 79 - 70, D = 69 - 60, F = 59 and below. You must have your Dean's approval if changes in the scale are made.

Grades earned in courses impact academic progression and financial aid status. Before withdrawing from a course, be sure to talk with your instructor and financial aid counselor about the implications of that course of action. Ds, Fs, Ws, WFs and Is also negatively impact academic progression and financial aid status.

The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop

periods are shorter for accelerated format courses. Please refer to the <u>academic calendar</u> for deadlines for add/drop. You must attend at least one meeting of all your classes during that period. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student, and a student may not be permitted to reenroll. Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.

For online and hybrid courses, check your Instructor's Course Information Sheet for any required on-site meeting times. Please note, instructors may require tests to be taken at approved testing sites, and if you use a testing center other than those provided by HGTC, the center may charge a fee for its services.

Testing in an **online/hybrid** course and in **make-up exam** situations may be accomplished in a variety of ways:

- Test administered within D2L.
- Test administered in writing on paper.
- Test administered through Publisher Platforms (which may have a fee associated with the usage)

Furthermore, tests may have time limits and/or require a proctor.

Testing candidates must make their appointments 24 hours in advance.

Students must bring a physical ID in order to take a test.

Proctoring can be accomplished either face-to-face at an approved site or online through our
