- A. Students will differentiate drama from other forms of literature.

1. Recognize the difference between acting and oral interpretation.
2. Effectively select and analyze a scene.
3. Identify the structural elements of a play.
4. Demonstrate effective cutting of solo/duo/group drama for performance.

#### **Module 4: Interpretation of Poetry**

##### **\*Assessments: Quiz/Test and/or In Class Exercises**

- A. Students will differentiate poetry from other forms of literature.
  1. Identify the types of poetry.
  2. Identify various types of figurative language used in poetry.
  3. Analyze poetic structure.
  4. Demonstrate oral interpretation of poetry.

#### **Module 5: Group Performance of Literature**

##### **\*Assessments: Quiz/Test and/or In Class Exercises**

- A. Student will demonstrate various forms of group performance.
  1. Identify the difference between readers theater and familiar theatrical conventions.
  2. Demonstrate effective compilation of scripts/literature.
  3. Practice directing group performance.

## GRADING SYSTEM:

Please note the College adheres to a 10 point grading scale A = 100 – 90, B = 89- 80, C = 79 – 70, D = 69 – 60, F = 59 and below. You must have your Dean's approval if changes in the scale are made.

Grades earned in courses impact academic progression and financial aid status. The Add/Drop Period is the first 5 days of the semester for **full term** classes. Add/Drop periods are shorter for accelerated format courses. If you do not, you will be dropped from the course(s) and your Financial Aid will be reduced accordingly.

## Part IV: Attendance

Horry-Georgetown Technical College maintains a general attendance policy requiring students to be present for a minimum of 80 percent (80%) of their classes in order to receive credit for any course. Due to the varied nature of courses taught at the college, some faculty may require up to 90 percent (90%) attendance. Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll. **Instructors define absentee limits for their class at the beginning of each term; please refer to the Instructor Course Information Sheet.**
