RATIONALE FOR THE COURSE: TUF 171 provides the student a basic understanding of turfgrass management practices so that they may effectively communicate with the golf course superintendent, athletic field managers, club members, owners, and employees under their supervision. This knowledge is also essential for making managerial decisions at a golf facility or athletic facility. This course is designed to meet these needs.

COURSE DESCRIPTION: This course is designed to introduce principles of turfgrass management and golf course operations to non-Golf Course Management majors. Topics include turfgrass selection, mowing commonly used golf course terminology, supplementary cultural practices, different types of golf course and the golf course management principles. The history and function of golf related organizations are also discussed in the course.

Pursuant to 34 Code of Federal Regulations 228.22 - Return to Title IV Funds, once a student has missed over 20% of the course or has missed two (2) consecutive weeks, the faculty is obligated to withdraw the student and a student may not be permitted to reenroll.
