### **RATIONALE FOR THE COURSE:**

WLD 201 is a required course in the Advanced Welding Technology Program. WLD 201 provides the welder with the knowledge to understand the materials being welded and also select the best possible welding process, and procedure to produce sound welds.

### **COURSE DESCRIPTION:**

This course covers the weldability of metals, weld failure, and the effects of heat on chemical, physical, and mechanical properties.

### **PREREQUISITES/CO-REQUISITES:**

COMPASS Reading 54, and Compass Pre-Algebra 40 Accuplacer Reading Comp032 and Accuplacer Arithmetic 043 or Accuplacer Elementary Algebra 057
